

EAST HOATHLY with HALLAND PARISH COUNCIL

DRAFT minutes of the meeting of the full council held on Monday 24th of June, 2019 at 7 pm at Buffalo Bill's (formerly The Forge), Halland.

Present: Cllr. Tony Pope (chairman), Cllr. Susan Cole, Cllr. Quinta Deane and Cllr. Chris Magness.

In attendance: Malcolm Ramsden (clerk), Verne Heath (rfo), County Cllr. Nick Bennett and four members of the public.

In the absence of the chairman and following a proposal by Cllr. Magness and seconding by Cllr. Deane

1. PUBLIC PARTICIPATION

Members of the public are welcome and encouraged to attend. The first fifteen minutes of the meeting will be available for the public to express a view or ask a question on relevant matters on the agenda. The public and members of the press are also welcome to stay and observe the rest of the meeting

Following on from a written representation by the Halland speedwatch group members reiterated the outcome of conversations held with representatives of the County Council Highways department that, in their view, positioning of rumble strips at the road leading into Halland from Heathfield would not be the most effective method for reducing traffic speeds. In addition to the building of 'gateways' at the entrance to the village, erecting a speed indicator device would appear to be more effective as the psychological advantage of the action of the driver creating the response from the device has been shown to be more likely to cause a positive response. Indeed, the benefit of such a device being mobile as opposed to being fixed in one position could be that a number of sites could be identified around the parish to increase its effectiveness. Members learnt that of more concern than the traffic speeds on the Heathfield Road was the speed of vehicles leaving the village towards Ringmer and that in an accident on that stretch within the last two months a number of vehicles had been involved. (See also agenda item No. 6.2.3).

2. REPORTS FROM COUNTY AND DISTRICT COUNCILLORS

Members learnt from County Cllr. Bennett that he has been elected to the post of deputy leader of East Sussex County Council but that he would still report back to this meeting as he has done in the past. This month's report covered the survey surrounding the possible closure of Fletching and Broad Oak schools and the continuing core budget shortfall of £26m which would result in approaching central government for further funding again this year. The next cabinet meeting of County Council would cover adult social care (with the county having the highest per capita figure in the country of "elderly and over 80's") which placed a significant demand on resources. Members congratulated County Cllr. Bennett on his appointment and thanked him for his offer to provide lobbying information details upon request.
